





What is EQA?



Comprehensive approach:

All mechanisms conducted by QA agencies to enhance <u>the</u> <u>quality of HE</u>

Focused approach:

Inspection?

- Fulfillment of minimum std + enhancement
- Quality assurance of processes (efficiency) and results (efficacy)
- Quality assurance to promote specific policies:
 - on public information, excellence, employability, mobility...
- Assuring costumer needs / consumer protection



What EQA's carry out?

- Checking units operating above threshold standards,
- Preventing inadequate institutions (gatekeeper)
- Helping institutions to improve (capacity building)
- Holding institutions to be accountable (achieving mission)
- Accountable for the use of funds
- Advice to the government
- Programmes that satisfy national specifications
- Establishing international relations

- International links






