Introduction

In accordance with the Act on the Universities of Catalunya (LUC), Agència per a la Qualitat del Sistema Universitari de Catalunya (AQU Catalunya) adopted the legal form of a public-law entity of the Generalitat (Autonomous Government) de Catalunya which adjusts its activity to private law, and it is linked to the Department competent in matters of universities, with its own legal status, full capacity to act, and its own assets for the performance of its functions.

AQU Catalunya is defined by the LUC as the main instrument for the promotion and assessment of quality and its objective is the assessment, accreditation and certification of quality in the field of the universities and centres of higher education of Catalunya. The bylaws of AQU Catalunya were approved in the year 2003 and regulate, among other matters, the structure, operation and composition of its bodies as well as all the competences that the LUC and the normative framework in force attributed to it. With respect to its functions, in 2003 AQU Catalunya focused its action on four strategic lines:

- Creation of a new entity: AQU Catalunya
- Quality assessment
- Assessment of university teaching staff
- Co-operation, promotion and communication

The passage from the former consortium to the creation of AQU Catalunya entailed the closing of one entity and the opening of a new one that had to assume the functions of its predecessor as well as the new attributions, competences and structure. It also had to adapt the existing governing bodies and create new ones, in accordance with the new framework that was established.

The transformation process obliges strict compliance with the legal requirement of rendering accounts on the activities carried out by AQU Catalunya in the year 2003 and also obliges that this report shall:

- Explain the new structure and operation of AQU Catalunya.
- Describe the actions carried out in order to face the new challenges.
- Express recognition for the support received from the Department of Universities, Research and Information Society, from the Catalan universities, and from all the people who collaborated to make it possible.

All processes of change unquestionably entail an internal restructuring that requires time to become consolidated and to operate to the full extent of its possibilities. Although it is evident



that it was necessary to make a change in form, this was not so with respect to the basic premises, that is to say, the essence. AQU Catalunya continues to maintain the firm will to keep working with the Catalan universities and with the DURSI to improve the Catalan university system, understanding quality as a method of improvement more than as a mere formality with which compliance is to be made.

It should be noted that all the activities that are mentioned here were carried out with the greatest dedication and rigour and with the will to carry on with the spirit of collaboration and of teamwork that was begun by the predecessor entity.

AQU Catalunya has the foundations of a solid agency, with European interest and projection, which watches out for the improvement of the Catalan university system, which stakes energetically on innovation and co-operation, which seeks internal excellence, which promotes the dissemination of quality and which works in accordance with a code of ethics. It does all this with the aim of working for the Catalan university system with the full conviction that quality is the assurance of improvement.



Objectives for the year 2003

AQU CATALUNYA

As was defined in the Activities Plan for 2003, the most important challenge to be faced was that of creating and starting up AQU Catalunya in order to confront, with efficacy and efficiency, the new context and attributions that were assigned to it. The consortium was to be transformed into AQU Catalunya, in accordance with the provisions of the LUC, without detriment to the activities that were under way and assuming the complex developments for the preparation of AQU Catalunya in the rendering of new services and the performance of new activities. At the same time it was wished to take advantage of the transformation process to make an analysis of strengths and weaknesses, with the will to define a new body that would be the heir to the valuable background and experience which had been acquired, and that would bring about a considerable improvement in the strong points and weak points which were detected.

In the first place, from the structural standpoint, it was necessary to adapt the existing governing bodies (President, Board of Directors, and Director) in accordance with the new framework established. It was necessary to appoint the President of AQU Catalunya; to set up the Board of Directors —the supreme governing body— with a new composition: *a*) the president of AQU Catalunya, *b*) the rectors of the Catalan public universities and the rector of the UOC, *c*) the rectors of the private universities (up to a maximum of three), *d*) the presidents of the social councils of the public universities, *e*) three academics of acknowledged prestige, *f*) two representatives of the Department competent in matters of universities, *g*) the presidents of the assessment committees, and *h*) the director of AQU Catalunya; and lastly, to appoint the director of AQU Catalunya.

Secondly, it was necessary to appoint the members and to set up the assessment bodies provided by the LUC —the Quality Assessment Committee, the Tenure-Track Lecturers and Collaborating Lecturers Committee, and the Research Assessment Committee— and the specific committees that were derived from them, and also to define their respective attributions.

Lastly, as a result of these far-reaching changes, it was necessary to restructure the internal operating unit in order to deal with the management of the new attributions and operation of AQU Catalunya.



QUALITY ASSESSMENT

The main objective of this line of work was to transform the structure and operation of AQU Catalunya in order to adapt it to the requirements of the new assessment bodies —the Quality Assessment Committee and the specific committees— and with a view to assuming the new attributions granted by the LUC, while continuing the activities which the former consortium had undertaken. By fields, the specific objectives were as follows:

Assessment of programmes:

- To establish the new projects for Assessments Programme 2003-2004.
- To analyse and assess the operation of the new methodology, bearing in mind the experience acquired and especially its adaptation to the European assessment model.
- To develop the respective agreements with the universities.
- To continue the participation in the European project TEEP (Transnational European Evaluation Project).
- To finish the programmes begun under the consortium Agència.

Assessment of systems:

 To carry out the certification of the quality systems of the universities for the assessment of teaching activity, in accordance with the criteria established by the Inter-university Council of Catalunya, at the request of the universities.

Accountability:

- To publish the Report 2002 on the process of quality assessment in the university system of Catalunya.
- To develop the Report 2003 on the process of quality assessment in the university system of Catalunya.

Development and innovation projects:

- To continue the adaptation of specific methodologies.
- To finish the project of the Pilot Plan on qualification and professionalisation at the universities.
- To develop the General Frameworks, which are documents that bring together the best practices implemented by the universities and the recommendations made by the experts in each of the respective fields.



TEACHING STAFF AND RESEARCH

The assessment of university teaching staff was one of the new attributions that the LUC granted to AQU Catalunya. Never having been carried out from Catalunya, this activity had to be planned and created from zero. For this reason, a specific ad hoc area was created within AQU Catalunya in order to manage and co-ordinate all the activities relating to this new attribution, as well as the activities addressed to the creation of the Tenure-Track Lecturers and Collaborating Lecturers Committee, the Research Assessment Committee, and their specific committees.

Specifically, the following objectives were set for 2003:

- Development of the model of assessment of university teaching staff for the preparation of reports for the contracting of teachers in the categories of tenure-track lecturer and collaborating lecturer.
- Establishment of the model of assessment of university teaching staff for the issuing of research accreditations and advanced research accreditations, which are also used for the contracting of teachers in the categories of tenured assistant professor and full professor.
- Establishment of the assessment model with the private universities for the assessment of the teaching and research of the teachers of these universities.
- Establishment of the rules of operation.
- Development of procedures and forms.
- Establishment of the criteria to be applied in assessment.
- Establishment and publication of convocations.
- Start-up of the administrative mechanisms in the Teaching Staff and Research Area.



PROMOTION, CO-OPERATION AND COMMUNICATION IN THE FIELD OF QUALITY

The former Agència already carried out tasks relating to promotion, co-operation and communication in the field of university quality, and the following objectives were set in this respect for 2003:

Promotion and communication:

- To develop a promotion plan that would allow the creation of a new image for AQU Catalunya as a whole (stationery, publications, web site, documents and other aspects).
- To prepare a new web site that would allow an improvement of communication with the users of AQU Catalunya.
- To redesign the termly newsletter and to begin to produce it in digital format.

Publishing and dissemination:

- To develop the necessary publications to disseminate the assessment results.
- To develop publications that will allow the dissemination of the methodological materials and the General Frameworks prepared by AQU Catalunya.
- To develop the books that are derived from the workshops for reflection and debate.

Training, co-operation and exchange:

- To organise a workshop for reflection and debate with Rovira i Virigili University.
- To establish all the necessary ties in order to maintain the close collaboration between the Catalan universities, the Administration and AQU Catalunya that allowed the former Agència to make substantial advances.
- To participate and co-operate with the associations and entities that have the same objective as AQU Catalunya.
- To participate in seminars and congresses while exporting the experiences created in AQU Catalunya.
- To co-operate on the European and international projects that either contribute added value to the Catalan university system as a whole or help to develop quality systems that will allow the university systems of other countries to advance.



Structure and operation

ORGANISATION CHART

As a result of its transformation by the LUC, AQU Catalunya established the following organisation chart in 2003:





GOVERNING BODIES

President

Dr Antoni Serra i Ramoneda was appointed president of AQU Catalunya by Decree 40/2003, dated 20th February. Among other functions, he is in charge of the following: to watch out for the achievement of the objectives that are set, to exercise the institutional representation of AQU Catalunya and to inform the Government of the Generalitat de Catalunya and the Catalan Parliament about the activity carried out.

The main attributions that are to be carried out by the Board of Directors are to approve the Activities Plan, to establish the policies and strategic objectives, and to approve the balance sheet, the income statement and the notes to the financial statement.

In 2003, the Board of Directors approved the proposal of Bylaws of AQU Catalunya and ratified the operating rules of the Quality Assessment Committee and of the Tenure-Track Lecturers and Collaborating Lecturers Committee. It also approved the proposals of appointment of the members of the assessment committees of AQU Catalunya that were submitted by the respective presidents. Lastly, it approved the Activities Plan of AQU Catalunya for 2003 and the preliminary project of the Activities Plan and the Budget for 2004.

Permanent Commission of the Board of Directors

The Permanent Commission of the Board of Directors approved its operating rules and ratified the transitional internal organisational structure for 2003, the model agreement with the Catalan public universities and the definitive budget of AQU Catalunya for 2003. Director

Dr Gemma Rauret i Dalmau was appointed director of AQU Catalunya by Resolution UNI/872/2003, dated 9th April. Among other tasks, she is in charge of the direction of AQU Catalunya, the full representation of its Board of Directors with respect to the performance of the resolutions that this body may adopt, and the administration of its assets and its legal representation.



ASSESSMENT BODIES

In order to carry out the new attributions in accordance with the structure established by the LUC, the assessment bodies of AQU Catalunya were formed, namely: the Quality Assessment Committee (CAQ), the Tenure-track Lecturers and Collaborating Lecturers Committee (CLiC) and the Research Assessment Committee (CAR). These three committees have approved their operating rules as well as the operating rules of the specific committees that are derived from them.

Quality Assessment Committee

The Quality Assessment Committee of AQU Catalunya (CAQ) was organised on 10 June. The new assessment programmes

Assessment programmes

Considering the new needs that appeared as a result of the progressive integration of the universities in the European Area of Higher Education, as set out in the Bologna Declaration for the year 2010, and the needs posed by the Catalan universities with respect to the implementation of quality systems, in 2003 AQU Catalunya designed and started up a total of three programmes, which seek to meet the challenges posed.

PRO-QU programme

This represents the continuation of the Pluri-Annual Assessments Plan, although it lends preference to the degree standards that have not yet been assessed. The base from which it starts out are the protocols applied in the pilot projects of Business Sciences and Engineering Sciences, and the incorporation of the most outstanding aspects with respect to the assurance of the quality of the European project TEEP (Transnational European Evaluation Project). AQU Catalunya carried out the calculation of the referents of the projects that participate in the PRO-QU programme (2003-2004). Likewise, it signed the respective agreements with the Catalan universities to assess the following degree standards:

The **DISSENY** programme

This is addressed to degree standards in order that they may confront the design of new curricula, incorporating criteria set out explicitly in the General Frameworks and, at the same time, so that they may fulfil the requirements derived from the present legal framework. AQU Catalunya began the preparation of a guide for designing curricula. This guide incorporated the criteria set out explicitly in the General Frameworks for designing new curricula and their revision, for assessing the students' learning, and for European integration. The objective of this guide was to take into consideration the aspects derived from the definition of the curricula itself, and also the aspects that affected the design process and its operative planning (aspects that are not covered by any other programme at State level).

SEGUIMENT programme

The purpose of this programme is to consolidate the culture of quality and of continuous improvement on the basis of a methodology tried out in the year 2000. The aim of the SEGUIMENT programme is to continue to carry out follow-ups of the improvement plans, taking into consideration the specific methodology and incorporating the mechanisms of assessment of quality assurance promoted in the TEEP project. AQU Catalunya signed an agreement with the UAB for the performance of the follow-up of the Law degree standard.

Assessment of centres that grant foreign degrees in Catalunya

Under commission from the DURSI, a system of assessment, authorisation and accreditation was prepared and approved for the centres that offer foreign degrees in Catalunya. The Specific Committee for the Quality Assessment of University Centres and Activities began the analysis of the methodology of assessment for the authorisation of centres that offer foreign degrees in Catalunya.



Study of the labour insertion of university graduates in the working world

The collaboration was unfolded with the social councils of the Catalan public universities for the undertaking of the second survey of university graduates.

Methodological development and innovation

Transnational European Evaluation Project (TEEP)

The TEEP project, which was co-ordinated by the European Network of Quality Agencies (ENQA) and managed by the British, Danish and Catalan agencies, was completed. It envisaged the transnational assessment of the degree standards in History, Physics and Veterinary Medicine. In this project, AQU Catalunya took charge of the co-ordination and management of the external assessment process of the faculties of Veterinary Medicine of the Autonomous University of Barcelona (UAB), the University of Ljubljana, the University of Glasgow and the University of Budapest.

The objective of this project was to identify the comparable criteria in the European sphere with respect to the quality of higher education, in order to achieve a European assessment model that will allow the future assessments to be carried out with pre-established common criteria.

The progress reports, approved by the group that led the TEEP project, were presented at the meeting of rectors and European political managers (Graz, 29-31 May); these people prepared the meeting of Ministers of Education, which was held on 19 September in Berlin.

After the meeting for the close and meta-assessment of the project, which included the participation of all the internal and external committees, the project was finished with the drafting and publication, by the ENQA and AQU Catalunya, of the transverse assessment report on the educations of Veterinary Medicine at the UAB, the University of Glasgow, the University of Budapest and the University of Ljubljana. Lastly, the project was presented at the plenary meeting of the ENQA, in Budapest (29-30 September) and it became the main referent in relation to transnational assessment.

Adaptation and development of methodologies

The adaptation of specific methodologies was finished in accordance with the assessment needs, as is the case of the guide to assessment of the insertion of graduates in the working world.

The development of the external assessment guide corresponding to the new assessment methodology was completed. It takes into consideration the establishment of validated



reference values, statistical data and indicators, and also the establishment of well defined assessment criteria. This model is also oriented towards the improvement of quality and the rendering of accounts to society, and it allows comparison of the degree of achievement of the objectives of quality of university training.

Assessment reports

2002 Report

The 2002 Report was finished, edited and made public to the media. Its purpose is to render accounts on the process of assessment of the quality of the university system in Catalunya. This process is carried out by applying the methodology developed by AQU Catalunya on the basis of the European assessment method, which consists of the following stages: firstly, an internal assessment carried out by the unit that is being assessed, with the preparation of an internal report on this phase; secondly, an external assessment, managed by AQU Catalunya, which assesses the respective unit on site and checks the conclusions of the internal report, after which an external report is prepared on this second phase; and lastly, the assessed unit prepares a reflection on the conclusions of both reports and develops an improvement plan for the following years. In parallel, on the basis of all the reports, AQU Catalunya prepares the annual report, which is made public.

The 2002 Report is based on all the reports received during the year. Consequently, it is based on the internal report prepared by the assessed unit and on the external report, thereby integrating both points of view and assuring the validity of the data set out in them.

With respect to the approval of the content of the 2002 Report, the committees of advisers for the various thematic areas (CAAT), formed by Spanish and international academics of acknowledged prestige in their respective fields, were in charge in validating the report and approving its content. These committees were also entrusted with pronouncing themselves on the claims that were lodged by the assessed units after studying the report.

The 2002 Report is divided into five major sections: an introduction that presents the principal recommendations derived from the assessment processes and the results of each of the assessments carried out, divided into four main areas (Humanities, Social Sciences, Sciences, and Technology). Lastly, the annexes present the composition of the various assessment committees, the members of the CAAT and the authors of the Report.
