

TERMS AND CONDITIONS FOR THE PRIZE DRAW FOR 3 iPHONES AMONG PARTICIPANTS IN THE AQU CATALUNYA EMPLOYMENT OUTCOMES SURVEY 2023

September 2022



ONE. OBJECT

The Agència per a la Qualitat del Sistema Universitari de Catalunya (hereinafter, **AQU Catalunya**) is a public law entity subject to private law, with its own legal status, its own assets and full capacity to fulfil its objectives, in accordance with Article 1.1 of Law 15/2015, of 21 July, on the Agència per a la Qualitat del Sistema Universitari de Catalunya (published in DOGC No. 6919, of 23 July 2015). The purpose of AQU Catalunya is to promote and guarantee the quality of higher education, in accordance with international and European academic and social standards of quality and in accordance with current regulations, and to provide stakeholders in higher education with criteria and benchmarks to achieve the highest standards of quality in the performance of their duties, meeting the interest that society has in quality higher education.

Among the functions of AQU Catalunya recognised by Law 15/2015, of 21 July, of particular note is the analysis of the development of higher education in order to provide universities with expert guidance and advice, thus contributing to the promotion of excellence in the services provided. In this regard, and with the aim of facilitating the analysis of the situation and evolution of higher education, the Agency prepares statistical information and indicators that help to expand public information that demonstrates the state of the quality of the services offered by universities, contributing to accountability to society.

In accordance with the applicable regulations and with the aim of fulfilling its recognised functions, AQU Catalunya prepares a three-yearly survey to determine the volume and quality of employment for graduates of bachelor's, master's and doctoral degree programmes, as well as for those graduating from programmes in higher arts education. This study provides the university system with information on the quality of employment and satisfaction with the training received in order to promote the continuous improvement of the university system. The latest survey will involve multi-modal fieldwork: an initial online phase (email) and a subsequent telephone-based phase.

In order to promote awareness and participation in the aforementioned survey, AQU Catalunya will hold, through its communication channels, a prize draw for three next-generation iPhones from among all those who meet the following conditions:

- a) They participated in the study, regardless of the university/higher arts community to which they belonged and the type of the fieldwork (electronic or telephone-based).
- b) Their questionnaire was classified as valid. A valid questionnaire is considered to be one that responds to at least the key variables: employment at the time of the survey, functions performed on the job and whether they would take the degree course again. This applies to questionnaires given both online and over the phone.



c) At the end of the questionnaire, either online or by telephone, they gave their consent to have their data processed for this purpose.

TWO. TERMS OF THE SURVEY AND PRIZE DRAW

The electronic survey will be active from 7 November 2022 through 4 December 2022. And in the telephone phase from 16 January 2023 to 28 April 2023¹. The drawing will take place on 29 September 2023 by means of a random selection tool that will choose the three winning graduates. In addition, the same random selection tool will be used to select two more graduates as reserves in the event that any of the original graduates selected do not opt for the prize within the established period or if it is impossible to contact them.

AQU Catalunya will notify the draw's three winning graduates of their prize preferably via the email addresses provided for participation in the study. In the absence of reported email addresses, the telephone numbers provided for participation in the study will be used for up to three calls during office hours (8 am to 3 pm, UTC +1). The individual notification to each winning graduate will indicate how to proceed to claim the prize and it will be necessary to respond within five working days from its receipt, counting from the same day of notification.

Should it prove impossible to contact the three people selected or if no response is received within the specified period, AQU Catalunya will contact the reserves in order, who will have the same period of five working days from receipt of the notification to claim the prize.

In order to be able to receive the prize, on the day of collection graduates will have to submit to AQU Catalunya a photocopy of a valid ID showing their NIF/DNI, name and surname and the municipality of residence for tax purposes.

The draw will be declared void in the event that none of the three selected graduates, or the reserves, claim the prize according to the procedure outlined in these Terms and Conditions. In this case, the draw will be carried out again with the remaining people who meet the requirements described above, to select a new set of winners and reserves, as stated in these Terms and Conditions.

The winning graduates authorise AQU Catalunya to publish their names as winners on the Agency website, as well as a photograph of them receiving the prize, if applicable.

AQU Catalunya guarantees that the draw is made on an equal opportunity basis among the different graduates who respond to the employment outcomes survey. Therefore, any abusive or fraudulent use of these Terms and Conditions will result in the cancellation of participation in the

draw. Each graduate's response to the survey will only be computed once, even if, for whatever reason, it may have been sent more than once.

THREE. THE PRIZE

The prize is an iPhone 13 smartphone, or a recent equivalent range, for each of the three winners.

The prize is personal and non-transferable. Likewise, in no case will the prize be subject to change, alteration or compensation. The approximate value of the smartphone is 950 euros.

FOUR, REQUIRED DATA AND PURPOSE

In order to take part in the prize draw governed by these Terms and Conditions, participants will have to accept the data release clause included in the questionnaire. This release of data is included in order to manage and carry out the draw, as well as to be able to contact the winners. It is not mandatory to accept the above clause. However, only those graduates who accept it will be included in the draw, so a non-response will be equivalent to the non-acceptance of data release.

FIVE. PERSONAL DATA

1. Lawfulness of processing and consent of the data subject

In accordance with Article 6 of Organic Law 3/2018, of December 5, on the protection of personal data and guarantee of digital rights, the present processing is based on the consent of the data subject and, therefore, the acceptance of the Terms and Conditions to participate in the draw constitutes its legitimate legal basis. Consent may be freely revoked at any time and its withdrawal will take effect from the moment of its communication.

2. Data controller

3. Purpose of processing

Management of the participation of graduates in the draw related to the AQU Catalunya employment outcomes survey 2023.

4. Data recipients

The sole recipient is AQU Catalunya.



No assignments to third parties or international data transfers are foreseen, unless it is a legal obligation.

5. Rights of participants

Participants in the employment outcomes survey can exercise before AQU Catalunya their rights of access, rectification, erasure, restriction, portability and opposition in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (GRPD), and with Organic Law 3/2018 of 5 December on the protection of personal data and guarantee of digital rights.

These data protection rights may be exercised before AQU Catalunya by sending a request from the <u>Contact us</u> section of the AQU Catalunya website, or by post to AQU Catalunya, Carrer d'Enric Granados, 33, 08007 Barcelona, or by any other means permitted by law.

6. Data storage period

The storage period of the data provided to hold the draw will be that necessary for the draw's management and delivery of the prize.

SIX. ACCEPTANCE OF THE TERMS AND CONDITIONS

The fact of indicating in the survey that one wishes to participate in this draw implies that the participating graduate fully accepts the Terms and Conditions and accepts the criteria of AQU Catalunya with respect to the resolution of any questions that may arise.

AQU Catalunya reserves the right to extend or modify these Terms and Conditions and even to cancel or void the contest if there is a justified cause. In the event of such an occurrence, it will be communicated by the same means and with the same degree of publicity given to the draw.

AQU Catalunya is exempt from any obligation or compensation to participants if, for reasons of force majeure, legal imperatives or other criteria of the Agency, the contest has to be cancelled or suspended.

SEVEN. COMMUNICATION TO THE AEAT AND REQUEST FOR PARTICIPANTS' TAX DATA

AQU Catalunya will notify the AEAT of the reception of the prize by the winning persons for the appropriate purposes.
